Membership fee - All exhibitors must be members of the Wentworth Show Society. Membership provides entry for 2 days for 4 adults. Tickets will be forwarded to you once all allocations have been made, and all exhibitors must have their tickets with them to gain entry to show grounds on show days. Extra tickets are available at \$12 per ticket.

Public Liability insurance – Public Liability Insurance of \$10m is required. The Show Society is instructed to collect a Certificate of Currency from each exhibitor. If you do not have adequate insurance (or cannot provide a Certificate of Currency), the Show Society must collect the fee of \$33 from you, which will cover you for the duration of the Show (2 days). Please note: your Certificate must indicate that your insurance is valid until at least 1st September 2017, and no site will be allocated unless you have the necessary insurance.

***All electrical equipment must have been tested and tagged prior to connection to any power at the Showgrounds. Please consider power needs carefully, as we only have limited supply. Please read attached important information, and inform us of all electrical equipment you are bringing.**
