### WENTWORTH ANNUAL SHOW TRADE SITE AND FOOD TENDER REGULATIONS SHOW DATES -25<sup>th</sup> & 26<sup>th</sup> AUGUST 2018.

#### APPLICATION & PAYMENTS

- 1) **APPLICATIONS CLOSE ON THE 6th AUGUST 2018, and payment in full must be received by that date.**
- 2) **All applicants for a trade site at Wentworth Show must complete and return the accompanying Trade Application Form together with payment and insurance compliance details WITHOUT DELAY to the Site Manager (address page 2). No form, No site. A description of the goods must be included. Fillable Forms may also be downloaded from our website and emailed to Geoff, see page 2 for email details.**
- 3) If space is not available, you will be advised by email/letter and a refund made.

**CHARGES:** These include charges for site fee and power if required plus camping and insurance if applicable. Membership is compulsory for all exhibitors. All costs shown include GST.

**MARQUEE:** No spaces will be allocated in the Marquee until payment in full has been received.

**PAYMENT:** Direct Credit to account **Bendigo Bank, BSB 633-000, A/c No 108765462**. Please include your ID# and company name in the narrative and advise that payment has been made. **Ensure your application form has also been returned to us.**

**GROUND ENTRY:** You will be issued with **4 entry tickets; additional tickets may be purchased at a discounted price of \$12.00 each.** All exhibitors must have their tickets with them in order to gain entry to the show grounds on show days. If for any reason your tickets have not been received please either check with the Site Manager on **0447 272 272** or call at the Secretary's office on Friday 24th August. **If tickets are not held, you will be charged the normal entry fee at the gate on show days and no refund will be given.**

**INSURANCE:** A copy of your Public Liability Insurance Policy (which must include your name) is to be included when booking space. This **must** be for \$10 million.

If you are a hobby stallholder, do not hold a current ABN and have an annual turnover less than \$10,000.00 you can be covered under the ASC's insurance upon payment of \$35.00. **Space will only be confirmed when this requirement is met.**

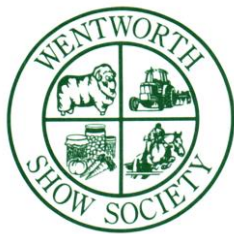
Owners of mechanical devices such as rides cannot be covered by the ASC's insurance. They must have their own \$20 million cover.

**ARRIVAL ON SHOWGROUND:** All site holders must check with the Site Manager before establishing camping &/or trading sites. Site holders who arrive outside business hours may camp in a temporary position (not in the Horse area) until a permanent site is allocated.

**The Site Manager will be in attendance from 8.30am on Friday 24th August 2018.**

**SITE HOLDERS ARE NOT TO PACK UP BEFORE 4pm ON SUNDAY. NO VEHICLES ARE TO BE MOVED BEFORE 4.30pm ON SUNDAY (EMERGENCY SERVICE VEHICLES EXCEPTED).**

**MACHINERY, TANKS etc:** Exhibitors are reminded that local Council regulations stipulate that all machinery, tanks etc, must be removed from the Showground within 7 days of completion of the Show.

### FOOD VENDORS:

**ALL NEW FOOD VENDORS CONTACT 0447 272 272 FOR ELIGIBILITY DETAILS.**

Please complete the attached **TEMPORARY EVENTS ALLOCATION TO SELL FOOD FORM** and return it to the Wentworth Shire Council. It **MUST** be received by them at least 5 days prior to the Show.

**ELECTRICAL EQUIPMENT:** All electrical equipment is to be fitted with earth leakage circuit breakers and all electrical leads, tools and appliances must have been inspected and tagged by a licensed electrical contractor and must be current or to be tagged within two hours of notice by the OH & S Officer. Any exhibitor who does not comply will not be permitted to exhibit at the Showground.

**GAS CYLINDERS:** Must have a current stamp of approval.

**SECURITY:** Exhibitors are responsible for adequately securing their property and that of their staff and accompanying persons and the Wentworth Show Society Inc. accepts no responsibility for damage or theft.

**PROHIBITED GOODS:** The sale of tobacco products and secondhand machinery or vehicles is prohibited. The use of public address or sound equipment is not permitted. Games-of-chance and collection tins/buckets are not permitted. If you are intending to run a raffle please note that tickets can only be sold from your Trade Site, any queries check with the Show Secretary.

**BANNED GOODS:** The following items are banned at all shows:-

- Drug Related Goods (including Cocaine Kits, Bongs etc)
- Explicit and Hardcore T - Shirts
- Fake Cigarettes
- Fireworks - Crackers
- Fuel Type Fire Lighters (Zippo)
- Horns and Trumpets
- Knives (including Pen Knives), (excluding appropriately packaged kitchenware sets)
- Laser Pointers
- Metal and Wooden Martial Art Nunchakas
- Playing cards (Nude or Lurid)
- Pressure Pack Snow
- Pressure Pack Fart Gas
- Silly String
- Stink Bombs
- Bouncing Beans
- Water bombs
- Electric Hands

Toy guns are acceptable, but the following are **NOT**:-

- Ball Bearing Guns
- Eight Shot Caps
- Pellet Guns
- Pop Downs (Throw Downs)
- Potato Guns (Bullet Type)
- Roll Caps
- Strip Caps
- Water Pistols over 150 mm (6")
- Replica Guns (Bullet Type)

Samurai swords, English swords and Fencing Swords are to be sold in sealed packages by Licensed Traders ONLY.

**The Show Society reserves the right to request that a site holder remove any item deemed to contravene these conditions.**

**PRICES:** All stall holders must have prices clearly displayed for goods and rides.
